1 OVERVIEW

This *TrafficJam Hardware Guide* describes the physical hardware of the TrafficJam traffic generator. The companion *User's Guide* describes the installation, configuration, and operation of the TrafficJam functionality. A separate *Quick Start Guide* provides a walk-through for first time configuration.



The TrafficJam contains no user serviceable parts. Opening the chassis voids the warranty. If you believe your unit is not functioning properly, see Section 5 for information on obtaining support.

3 FRONT AND REAR PANELS

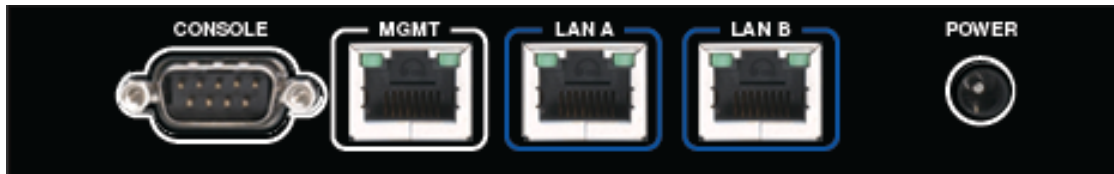
3.1 Front Panel



The front panel of the TrafficJam contains:

Power LED: Lit green when the unit is powered on. Unlit when power is off.

3.2 Rear Panel



The rear panel of the TrafficJam contains:

CONSOLE: Console interface using RS-232 with a DB-9 connector.

MGMT: 10/100/1000baseT Ethernet interface with a standard RJ-45 plug for browser-based management of the unit over the network.

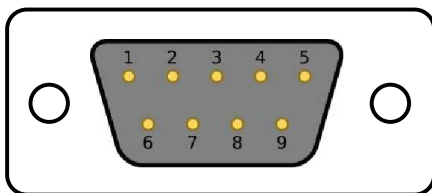
LAN A: 10/100/1000baseT Ethernet interface with a standard RJ-45 plug. Connects to the network segment functioning as LAN A in network emulations.

LAN B: 10/100/1000baseT Ethernet interface with a standard RJ-45 plug. Connects to the network segment functioning as LAN B in network emulations.

Power input: 12V DC power, 2.5 mm center positive input.

4 CONSOLE INTERFACE

Console access to the TrafficJam is through the RS-232 interface on the rear panel labeled "CONSOLE." A DB-9 cable is included with the unit to connect the device to a standard PC serial port. The pin-out for the DB-9 connector is shown below:

To connect to the console, use a terminal or a computer running terminal emulation software, and set the following parameters:

- 9600 baud
- 8 data bits
- No parity
- 1 stop bit
- Disable flow control

Title and Restrictions

Apposite retains all right, title and interest in the Software and Documentation. The Software and Documentation are protected by United States and international copyright and other intellectual property laws and international trade provisions. Except as otherwise expressly provided under this Agreement, you shall not directly or authorize any third party to:
